Please be advised that the [Safety Code Fees](#) administered by Palliser Regional Municipal Services has changed effective January 1, 2017.

Over the course of 2016, a Request for Proposals (RFP) was created to access new potential Safety Codes service providers, as the contract with Superior Safety Codes Inc. had expired. Through the RFP process, only two (2) proposals were received. In conjunction with the Town

of Drumheller, the submissions were assessed relative to costs and levels of service proposed and in October, the Board of Directors for Palliser Regional Municipal Services voted to enter into a new 3 year contract with Superior Safety Code Services Inc.

The current fee schedule reflects cost recovery requirements for both the inspections and administration of the service, in keeping with provincially mandated directives.
